

## QUESTIONS FOR YOUR REPRESENTATIVES

### AMENDMENTS TO THE INTERNATIONAL HEALTH REGULATIONS (IHR)

Q1: Are you aware of the proposed amendments to the International Health regulations?

The proposed amendments would:

1. **CHANGE THE NATURE OF THE W.H.O. (World Health Organization) FROM ADVISORY TO MANDATORY:** **Australia would lose its ability to act autonomously.**
2. **CAUSE LOSS OF SOVEREIGNTY:** **Australian sovereignty would be ceded to the unelected WHO.**
3. **DISREGARD DIGNITY, HUMAN RIGHTS AND FREEDOMS:** **Even the WHO's own working party has rejected this clause, but there is no decision on their recommendations. What reasonable body acting FOR the people would remove "human rights and fundamental freedoms"?**
4. **ENABLE ACTION ON POTENTIAL RATHER THAN ACTUAL EMERGENCIES:** **The unelected Regional Director of the WHO could act on suspicion of a potential issue, with no proof required.**
5. **ENFORCE MANDATORY MEDICAL TREATMENTS:** **Removes bodily autonomy for the entire population, including our children.**
6. **ENFORCE GLOBAL HEALTH CERTIFICATES:** **This would give an international, unelected Director General full control and oversight of the world populations location, travel plans and medical information. An obvious national security risk of huge proportions.**
7. **ENFORCE SURVEILLANCE OF PEOPLE AND THEIR INTERACTION WITH ALL MEDIA:** **Mass surveillance systems have already been developed within Australia enabling tracking of movements and information transfer, which is a violation of free speech.**
